## ANNEX TO ARTICLES OF INCORPORATION

Pursuant to the Colorado Revised Nonprofit Corporation Act, Articles 121 to 137, Title 7, C.R.S., this Annex to the Articles of Incorporation is delivered to the Colorado Secretary of State for filing.

## DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon dissolution, the assets of the Association will be distributed to the Owners in accordance with the Colorado Common Interest Ownership Act, codified as amended, at Colorado Revised Statutes 38-33.3-218.

### **POWERS**

In furtherance of the purposes stated above, the Association shall have and may exercise all of the rights, powers, privileges, and immunities now or subsequently conferred upon nonprofit corporations organized under the laws of the State of Colorado and as more particularly granted by the Colorado Nonprofit Corporations Act, the Colorado Common Interest Ownership Act, and the Condominium Declaration of 1201 Balsam.
